Dear Chairwoman Granger and Ranking Member DeLauro:

I am requesting funding for Central Road: Barrington Rd to Huntington Blvd project in fiscal year 2024. The entity to receive funding for this project is Cook County Department of Transportation and Highways, located at 69 W Washington Street, Suite 2400, Chicago, IL 60602. The funding would be used for rebuilding Central Road to modern standards and would provide a new off-street shared-use path. Reconstructing the roadway with the addition of a multi-use path creates a better connection between public goods and services such as the Barrington Road and I-90 Pace bus stop or the Paul Douglas Preserve trails in the Cook County Forest Preserves. The project also supports the Bell Works redevelopment of the former AT&T site in Hoffman Estates. The shared-use path will also provide safe travel for bikes and pedestrians to the existing Hoffman Estates network of bike/pedestrian side paths and other regional trail networks such as the Popular Creek Trail. The project is an appropriate use of taxpayer funds because it improves infrastructure. The project has a federal nexus because the funding provided is for purposes authorized by 23 USC 133.
