I am requesting funding for the Schaumburg Road Multi-Use Path at Schaumburg Road between IL Route 59 (Sutton Road) and East Avenue and along Old Church Road from Schaumburg Road to Barrington Road Streamwood, IL 60107 in fiscal year 2027. The entity to receive funding for this project is the Village of Streamwood. The funding would be used to build a shared-use path along Schaumburg Road between IL Route 59 (Sutton Road) and East Avenue as well as a shared-use path along Old Church Road from Schaumburg Road to Barrington Road. The project is an appropriate use of taxpayer funds because the selected corridor was identified as a priority in the Village of Streamwood's 2018 Comprehensive Plan and a Tier 1 priority in CMAP's Bartlett and Streamwood Pedestrian and Bicycle Plan and has already been through the public approval process.

The project has a federal nexus because of 5305(a)(2) - the acquisition, construction, reconstruction, or installation (including design features and improvements with respect to such construction, reconstruction, or installation that promote energy efficiency) of public works, facilities (except for buildings for the general conduct of government), and site or other improvements.
